## **WEINSTEIN NAMED PCT FRIEND OF EDUCATION**

At the annual PCT party to welcome our newest members and to honor our June retirees, our union from time to time honors an outstanding person who has made an unusual contribution to our school district. This year's honoree is Lori Weinstein, past president PTA Council.



The officers of the PCT chose to honor Ms. Weinstein based on their experiences working with her over the years that she has been a part of the school

community. The plaque presented to her by PCT President Morty Rosenfeld cited Lori "...for her tireless work on behalf of the children of the Plainview-Old Bethpage Central School District, her advocacy for academic excellence and high academic standards, her deep appreciation for the work of the teachers and educational support professionals of our school district and for being an example to all of giving back to one's community."

## **GRIEVANCES**

Over the past few days PCT Grievance Officer Judi Alexanderson has reported the filing of a number of violations of our contract or what are called grievances.

These violations include the following:

1 - The assignment of members of the Substitute Unit of the PCT to cover the high school in school suspension center, a job previously done by teachers but cut from the budget last year. The theory of our case is that substitutes have to substitute for an absent teacher.

2- The assignment of the high school teacher who assists the school with student attendance for three (3) periods of his teaching assignment to three (3) periods in the in school suspension center, both jobs to be done at the same time.

3- The assignment of members of the Substitute Unit of the PCT to lunch room duty during period 5 and hall duty period 9 at the POB Middle School. These substitutes don't seem to be substituting for anyone either.

4 - The failure of the District to assign a certified and qualified member to the drama cadets position for which he applied and the assigning of that position to an outsider to the district. This position and all other extra-curricular positions belong to the membership of the teacher bargaining unit of the PCT.

Judi also reports that the PCT has filed demands with the district to negotiate over some of these matters in that the rules of the Public Employees Relations Board (PERB) require that they do so. If these negotiations prove unfruitful, the PCT will be filing improper practice charges with PERB.

## **PCT SUPPORTS PTA BLOOD DRIVE**

The PCT is a proud supporter of the annual blood drive of the PTA Council. The Council has set the goal of increasing the donations to their blood drive by 50% this year. The drive will take place on Thursday, December 7 from 11 AM to 9:15 PM at the Plainview Middle School.

PCT members are encouraged to donate blood. As we approach the holiday season, blood

donations tend to fall causing life-threatening shortages at area hospitals. Let's help the PTA reach its goal.

## **OBSERVATIONS**

The administrators of some of our schools have been talking to their staffs about alternatives to formal observations.

The PCT has a long standing position of believing observations of tenured teachers to be essentially meaningless, having little to do with the improvement of education and much to do with administrative coercion. In fact, the officers of our union have raised this subject with the Superintendent in the past but we were unable to come to any agreement on a suitable alternative.

If we are again to raise this subject, PCT members are advised that it must be done in an official manner. We cannot allow an evaluation process to develop that is different from building to building and or perhaps even within a building.

The evaluation of teachers is part of our contract and therefore must be negotiated. As PCT President Morty Rosenfeld said at a recent SRC meeting at the Stratford Road School, "while we don't like the process, we need to remember that 99.9% of the observations that are written are positive. It is very helpful to a PCT advocate who has to represent a teacher who has had a lapse of judgement to have a file filled with good observations to point to in the teacher's defense."

## **DISCIPLINE**

The officers of the PCT have been frequently hearing from members about their perception that they are working with more and more unruly children. In an attempt to get a handle on this issue, they have put it on the agenda for the November PCT Executive Board meeting. Members are encourage to share their thoughts on the subject with their SRC Reps.
